GENERAL TERMS

1. The promoter of the Lucky Draw is the ATC of Royal Randwick Racecourse, Alison Road, Randwick, NSW 2031, telephone: +61 2 9663 8400.
2. The Lucky Draw is a game of chance and not skill and will be conducted randomly by computer selection.
3. Rules on how to enter the Lucky Draw form part of these General Terms of entry. By entering the Lucky Draw or accepting a prize, entrants agree to be bound by these General Terms.
4. Entry to the Lucky Draw will be refused or an entrant disqualified if an entrant does not comply with these General Terms. The ATC reserves the right to verify the validity of entries and disqualify any entrant for tampering, or attempting to tamper with the entry process.
5. Officers, management, staff and sponsors of the ATC and their immediate families are not eligible to enter the Lucky Draw.
6. To be eligible for the Lucky Draw an entrant must be on course at Rosehill Gardens (**Racecourse**) on Girls Day Out presented by BOOHOO.com, 18 November 2017 (**Race Day**).

To enter, entrants must visit the unique Lucky Draw webpage (**Website**) and complete the entry form (**Entry Form**) and provide all required details, including a nominated address (**Address**). The Website will be active from the time gates open until 6:00pm AEDT on Race Day. 26. These General Terms are governed by the laws of New South Wales and entrants agree to submit to the non-exclusive jurisdiction of the Courts of New South Wales.
